In 1994, the Washington State Legislature enacted the Youth Violence Reduction Act that formed Community Public Health and Safety Networks throughout the state to plan, implement, fund and monitor activities designed to reduce problem behaviors of children and families in each locale. The Division of Developmental Disabilities (DDD) is part of the Department of Social and Health Services (DSHS) and Aging and Disabilities and Administration (ADSA). DDD assists individuals with developmental disabilities and their families to obtain services and supports based on individual preferences, capabilities and needs. DDD uses state and federal funds to provide or purchase supports and services for eligible persons and their families. Resources are limited and needed services may or may not be available. Development disabilities include mental retardation, cerebral palsy, epilepsy, autism, and neurological or other condition similar to mental retardation (including developmental delay). An individual with a developmental disability may be eligible for DDD services when the onset of the disability occurred before age 18, the disability is expected to continue indefinitely, and the disability resulted in substantial limitations to the person's adaptive functioning.

**Services Provided:** Case Management: If you are determined DDD eligible, you will be assigned a case resource manager to assist you and your family to identify interests and support needs, coordinate planning and development of resources; and monitor service delivery. Medicaid/Waiver Personal CARE (MPC/WPC): MPC/WPC services include supervision or hands-on assistance with personal care tasks for individuals that meet functional and financial eligibility criteria. This assistance is provided in the persons own home, and adult family home (AFH), or an adult residential care center (ARC). MPC is a service provided under the Medicaid State Plan and is available to persons who meet the functional and financial eligibility criteria of the Categorically Need Program (CNP). Employment: Ongoing support services and training for eligible persons to obtain and maintain paid jobs in a variety of settings and worksites. May include individual or group options in the community or prevocational services to help people move towards employment. Community Access: Activities, special assistance, advocacy and education to help eligible persons age 62 and older participate actively in their community. Infant Toddler Early Intervention Program: Early intervention services, including family resources coordination, for eligible children from birth to age 3 and their families. Individual & Family Services Program: Provides an array of services to families to help maintain and stabilize the family unit. Friends of Children Walla Walla was formed by a group of community leaders that coalesced around a strong concern for young persons in the Walla Walla Valley. Begun in 1999, the organization built its services upon the concept that a safe, consistent relationship with a caring adult outside the home can help a young person negotiate the developmental challenges that all youth inevitably face. By nurturing a child's strengths and self-esteem, the friendship reduces the child's vulnerability to risk factors. From the inception of this home-grown, local, non-profit mentoring organization, there has been a commitment to screening, training and ongoing support of adult volunteers as well as a focus on creating an appropriate match of adult and child. Since the first Friends "match" was made in 1999, fully 400 children have been served in the program, and there are currently over 110 active matches supported by the organization. Within the past two years, Friends has added a new, exciting program to its traditional, Community-Based (CB) services. While the latter is built on a one-year commitment from an adult who sees their matched young friend weekly, one-on-one in the community, the new ABC (Adults Befriending Children) Program requires a commitment lasting a school year, and all contacts take place on school grounds during school time. Together, the two programs form a solid approach to mentoring young persons in the Walla Walla Valley.

It is OFCO's mission to protect children and families from potentially harmful acts or omissions by governmental agencies, as well as to ensure that agency officials and state policy makers are made aware of chronic problems in the child protection and welfare system so they can improve state services. OFCO fulfills its mission by intervening in situations where it has determined that an agency's act or omission has placed the safety, well-being or interests of a child or family at risk of clear harm and by investigating workers actions and systemic issues that potentially are having a harmful impact on children and families. At the conclusion of an investigation, OFCO may mediate a resolution, recommend that an agency take specific action, or it may propose corrections to existing law, policies or procedures to agency officials, the Governor, or to the Legislature.
